The essence and component composition of the future teacher's media competence

Abstract. In the context of Informatization of society, considerable importance in the higher education system is given to the formation of media competence among students of pedagogical specialties as the most important professional quality of the individual. The media competence of the future teacher is represented in the research of many foreign and domestic specialists, who consider it both as the goal of the educational process and as its personal result. However, a comprehensive analysis of the component composition of media competence leads to the conclusion that the component that determines the individual and personal strategy of professional education is insufficiently studied. In this regard, the purpose of the study is to substantiate the significance of the personal component of media competence of students of pedagogical specialties for its further study and formation. The study author's definition of media competence of a future teacher, analyzed component composition of media education and explains the importance of personal component of media competence of students of pedagogical specialties.
